

## Skiing in Špindl on Friday

Špindlerův Mlýn - December 8, 2021 –

The most famous ski resort in the Czech Republic starts skiing on Friday, December 10. Excellent conditions for snowmaking made it possible for skiers in Špindlerův Mlýn to prepare a decent package of slopes for the start of the season.

They started snowing in Špindl in the last week of November. The intention to catch the planned Špindl Ski Opening traditionally during the second weekend of December was thus fulfilled to the letter. "We haven't had such conditions at the beginning of the season for a long time. We believe that the weather will last and we will be able to please skiers at the beginning of the season with a nice portion of open slopes in Svatý Petr, Horní Mísečky, Medvědín, and if all goes well, we would like to make the legendary Stoh piste accessible to connoisseurs. We dedicate all our energy to preparing a quality ski resort and we believe that thanks to that the season will be perfect," said Adam Svačina, sales and marketing manager of the Špindlerův Mlýn Ski Resort. In addition to the cable cars and slopes, skiers will have a restaurant, ski equipment rental and Skol Max ski school available from the first day of the 2021/22 ski season.

The operation of the ski area will be in accordance with the conditions and preventive regulations issued by the Government of the Czech Republic. "The basis is that only skiers who prove themselves with a valid ON certificate (vaccination, overcome disease) can get on the cable cars and lifts. Document control will take place when purchasing online or even directly at the cash register. This condition does not apply to children under 12 years of age and also to juniors aged 12-18 who can prove a negative test for COVID-19. The public will find detailed



information on the measures in force at the ski resort and the current list of slopes ready for opening on the [skiareal.cz](http://skiareal.cz) website, "added Svačina.

The pre-sale of ski passes for the 2021/22 ski season started online on [gopass.travel](http://gopass.travel) on 23 November. The ski pass pre-sale system is reminiscent of airline tickets - thanks to flexible prices, the following applies: the sooner you buy, the cheaper you ski. Ski pass prices for individual days depend on demand, weather and other inputs. The highest ski pass prices will be at the stone box office. There is also a seasonal PREMIUM Smart Season ski pass. Its owners can ski indefinitely in 10 resorts in 4 European countries - in addition to Špindl and Ještěd, in the Slovak resorts of Jasná and Vysoké Tatry, Szczyrk in Poland or in the Austrian resorts of Mölltal Glacier, Ankogel and Muttereralp Innsbruck.

(TMR) is a top tourism entity in Central and Eastern Europe that owns or rents and operates attractive mountain resorts, amusement parks, golf resorts, restaurants, sports services, shops and hotels. In the Low Tatras in Slovakia, TMR owns and operates the Jasná Low Tatras resort and Grand Jasná hotels, Hotel Tři Studničky, Chalets Jasná Collection, Hotel Srdiečko, Hotel Pošta and Hotel Rotunda. TMR is also the owner of Aquapark Tatralandia. It is the largest Slovak water park with year-round operation, which offers not only water entertainment but also Tropical Paradise - a special tropical hall with sea water as well as entertainment in the Fun Park and accommodation in bungalows and apartments Holiday Village Tatralandia. In the High Tatras, TMR owns and operates the High Tatras resort with the mountain localities of Tatranská Lomnica, Starý Smokovec and Štrbské Pleso. In the Slovak High Tatras TMR also owns hotels Grandhotel Praha Tatranská Lomnica, Grandhotel Starý Smokovec, Hotel FIS Štrbské Pleso and Noc na

Lomnický štít. In Austria, the Group owns and operates the Mölltal Glacier Alpine Resort and its sister resort, Ankogel Mallnitz. In the Czech Republic, it also indirectly owns a minority stake in Melida, a.s., which leases and operates the Špindlerův Mlýn center. TMR also leases and operates the Czech Ještěd ski resort, Golf & Ski Resort Ostravice and leases Kaskáda Golf Rezort Brno, where it covers the operation of the hotel, restaurant and congress center. In Poland, TMR owns and operates the Szczyrk Mountain Resort and Legendiu - Silesian Amusement Park (Śląskie Wesołe Miasteczko). As part of real estate projects, the Group mainly focuses on the development, construction and sale of apartments and commercial premises and the rental of hotels in TMR departments. By the end of the financial year 2019, approx. EUR 400 million. TMR shares are traded on three European stock exchanges in Bratislava, Prague and Warsaw.
